Introduction



The project Regional Youth Compact for Europe has started in spring 2018, when I met Stanka Parać, director of Local Democracy Agency Subotica who introduced me with the work of LDAs (Local Democracy Agencies) from the Western Balkans. During this meeting in Subotica, we agreed that a strong partnership between the CSOs with outstanding expertise in EU integration and the CSOs (Civil Society Organizations) with a long - standing experience in working with local communities could become a consolidating component for the creation of a new regional thematic CSO network. That is how the Center for Democracy Foundation was pleased to accept this invitation to be the lead partner and how CRTA from Serbia, Youth Act from Albania and SODEM from Turkey became partners. This is exactly how this eventful and above all, adventurous journey started in spring 2018!

The unique quality of this journey was evidenced at the kick-off meeting organized by the European Commission in Brussels in June 2018, attended by all the lead partners of the projects which the EU supported within the program Consolidation of Regional Networks. Whenever I was introducing myself or was presenting our project to EC staff members, they were saying, with astonishment, "Oh, that is you with 14 partners on the project!" Although numerous consortium also seemed to me a bit complicated to manage, their reaction scared me. "Is it really going to be so difficult?", I kept on asking myself.

However, it turned out it was not that much difficult. We in the Foundation learnt quickly that all our partners were experienced in working with different donors as partners. And we discovered to which extent they are committed to the cause of local democracy and to the mission of both their own organisations and that of ALDA, the network to which all LDAs belong and which transferred a lot of organizational culture to LDAs in the region. Of course, this organisational culture is practiced with more or less zeal by different organisations, but it certainly shapes LDAs work. So, we got to know each other and our joint work started.

We had identified two major target groups - CSOs, including our network members, and youth organisations. Our objective was to empower them, connect them and encourage them for greater role in monitoring reforms, in structured dialogue with governments, both on local and national level. We focused on two areas that are crucial for the citizens - the first one includes issues belonging to the chapter 23 (part of the EU accession negotiations on judiciary, fundamental rights) - democracy, rule of law and fundamental rights, and the second one which relates to social dimension of the EU integration process - employment, social policy and fight against poverty.

Our key activities were undertaken in LDAs communities, as well as on the regional level, such as Politeia School or Youth Fund "We have a Say". We advocated for acceleration of reforms, for inclusive dialogue among stakeholders, for active citizenry, and for regional cooperation. We promoted European values and presented EU assistance to the region.

The outbreak of the Covid19 pandemic happened in the second year of the project, when the most of our activities at local level were planned and when the project team had to react promptly in a well - coordinated manner. This meant that we started learning new skills and adjusting to the new reality of digital platforms and online events. However, along this turbulent times and waves of pandemic, we lost our dearest colleague and friend - Sasa Marinkov, Delegate of LDA Knjazevac.

In many ways, our three-year long journey became a life learning experience for all. His contribution to this project, his politeness and a coaching role he had in our personal lives will always be remembered.

Key achievements of this three-year project that all the partners would certainly agree on, are the following ones:

- CSOs in the Western Balkans were empowered to increase their participation in the reform process which will bring us closer to the European Union, to participate in a public dialogue and influence politics
- We brought the process of EU integration closer to citizens: Thousands of citizens on local level, in various parts of the region, were involved in debates, workshops, forums, conferences – benefiting from a variety of tools and channels for dialogue with policy makers, businesses, civil society organizations or they were approached by our products – newsletters, media appearances, social networks...
- Hundreds of young people from all over Western Balkans participated in the activities – learning a lot, debating even more, exchanging knowledge and practice, starting initiatives, creating projects...
- Local youth organizations from the Western Balkans received grants for their respective projects which brought valuable results to their local communities
- Politeia School became a regional program and a digital platform for development and education
- Balkan Network for Local Democracy was officially registered as a network and it strengthened its capacities and expanded its experience and outreach
- ALDA and its members have reiterated their presence in the Western Balkans.

These three years of our working together were certainly an empowering experience for all of us. The lessons learned and the experience collected will be the basis for our future endeavors. And, certainly, we will not mind big consortiums with such excellent members.

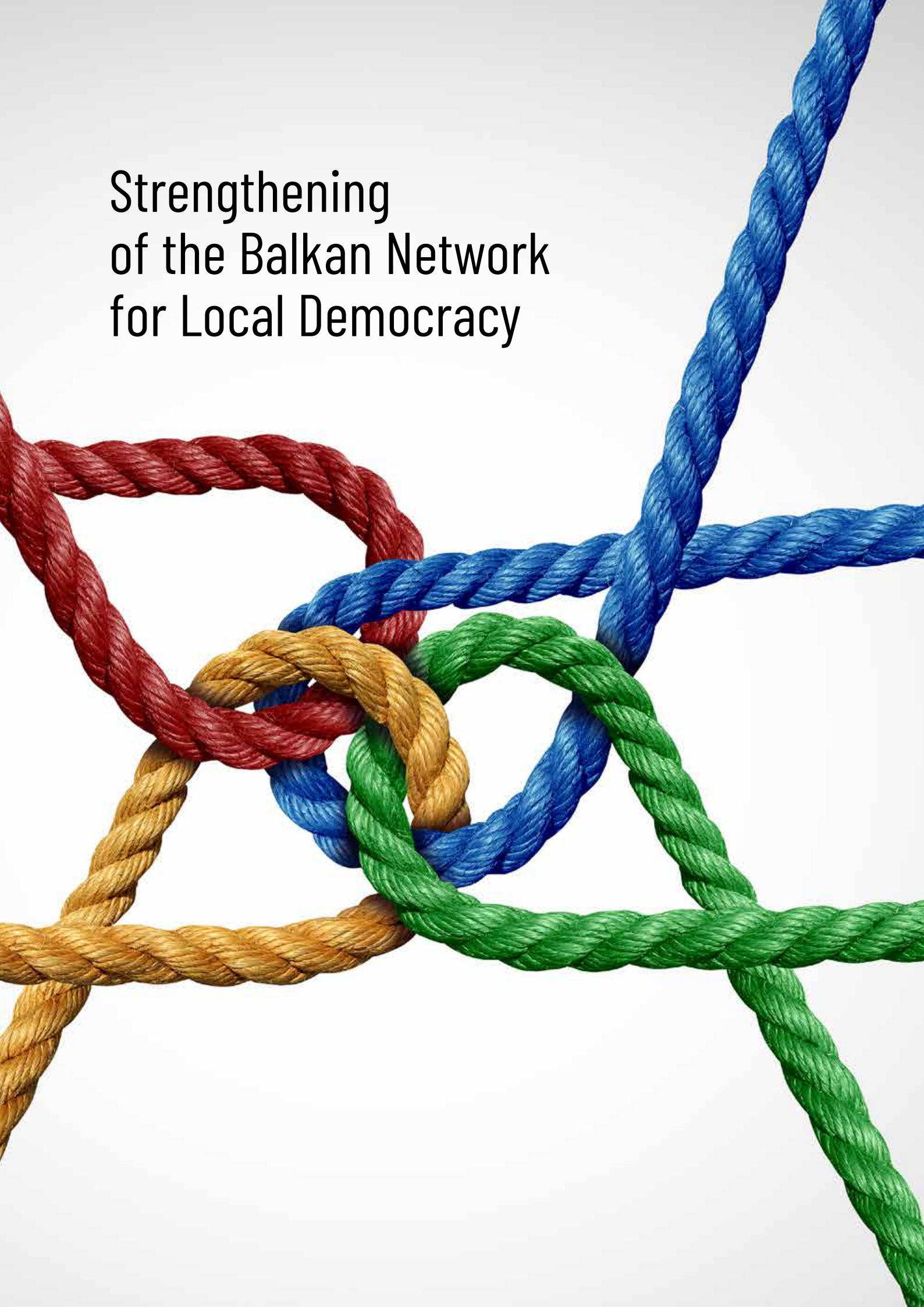

The “Regional Youth Compact for Europe” project has been very significant for the Balkan Network for Local Democracy.

Supported under the framework of the Civil Society Facility and Media Programme 2016 – 2017 Consolidating Regional Thematic Networks of Civil Society Organizations by the European Commission, the project lasted for 39 months, starting from April 2018.

The project represents consolidate regional exchange platforms in order to foster participative culture of young people on local level, focusing its activities in the local communities hosting the LDAs. It was therefore created in accordance with BNLD development strategy and commitment to address existing challenges and regional development.

The project provided direct support to the Network, through capacity building activities, exchange platforms, research, and facilitating networks and connections between Civil Society Organizations and Local Authorities. Through the implementation of the project activities, BNLD has worked with local stakeholders to build regional engagement and active citizen participation. BNLD’s work in the region incorporated activities from capacity building of local action planning to development of local engagement strategies. In addition, the project brought significant change in the internal capacity and structure of the Network by providing capacity building for its members in forms of training, coaching and mentorship.

Throughout the “Regional Youth Compact for Europe” project, BNLD reinforced its commitment to support regional cooperation and EU integration processes in the Region as well as to promote local democracy and citizen participation as a precondition for local sustainable development.

The Regional Youth Compact for Europe project key aim was to strengthen the Balkan Network for Local Democracy.



About BNLD



Balkan Network for Local Democracy (BNLD) is a regional network promoting active citizen participation, democratic governance principles, local development, and co-operation between civil society organizations and local public authorities in the Western Balkan Region.

BNLD is founded by the European Association for local democracy (ALDA) and the 7 Local Democracy Agencies (LDA) from Western Balkans aiming to support regional cooperation. BNLD action is based on the principle of partnership and multilateral decentralized cooperation.

BNLD has been initially functioned for several years as an informal network of Local Democracy Agencies, and since September 2019 it is established as an independent legal entity founded in North Macedonia.

The vision of BNLD is to contribute to good neighborhood relations, regional stability and prosperity based on good local governance, while supporting a culture of dialogue and respect of diversity in Western Balkans.

The mission of BNLD is to empower civil society and local authorities to jointly engage in democratic reform processes and local democracy principles, and to support regional cooperation and policy dialogue towards EU integration of the Western Balkans region.

BNLD History

The origins of the Balkan Network for Local Democracy (BNLD) should be traced to the initiative of the Council of Europe for the creation of Local Democracy Agencies (LDA) as independent civil society organizations operating at local level across the Balkans and ALDA as their umbrella organization with the mission to enhance their regional cooperation.

Since their founding, LDAs established in the Western Balkan countries share an uninterrupted history of promoting European values of local democracy, good governance, and respect for human and minority rights in local multi-ethnic communities. Valuable expertise in these topics combined with civil society development practices have been accumulated over the past decades through collaborative designing and implementation of specific actions at the local, national, cross-border, and regional levels. LDAs have demonstrated both a dedication to working closely with the host city authorities and with diverse local stakeholders on one side, and a strong allegiance to building inter-municipal, cross-border and regional co-operation network on the other side.

After extensive work for more than two decades, back in 2010, both the LDAs and ALDA recognized the need for closer and more structured joint thematic regional cooperation on common issues identified within the countries of the Western Balkans. Creation of the Balkan Network for Local Democracy is the expression of maturity of the LDAs and ALDA who have demonstrated a substantial local expertise, and a firm commitment to elevating their operational and organizational capacity at a new level of functioning.

By the end of 2014, the European Union recognized our efforts and supported the 4 year-long project "Balkan Regional Platform for Youth Participation and Dialogue". It is through this project that the Balkan Network for Local Democracy (BNLD) has been created.

From 2015 and on, the LDAs and ALDA have been fully focusing on regional initiatives while at the same time building up the idea to officially establish a network that would promote local democracy and regional cooperation in Western Balkans. This extensive collaboration resulted with official registration of the Balkan Network for Local Democracy BNLD in Skopje, North Macedonia in 2019.

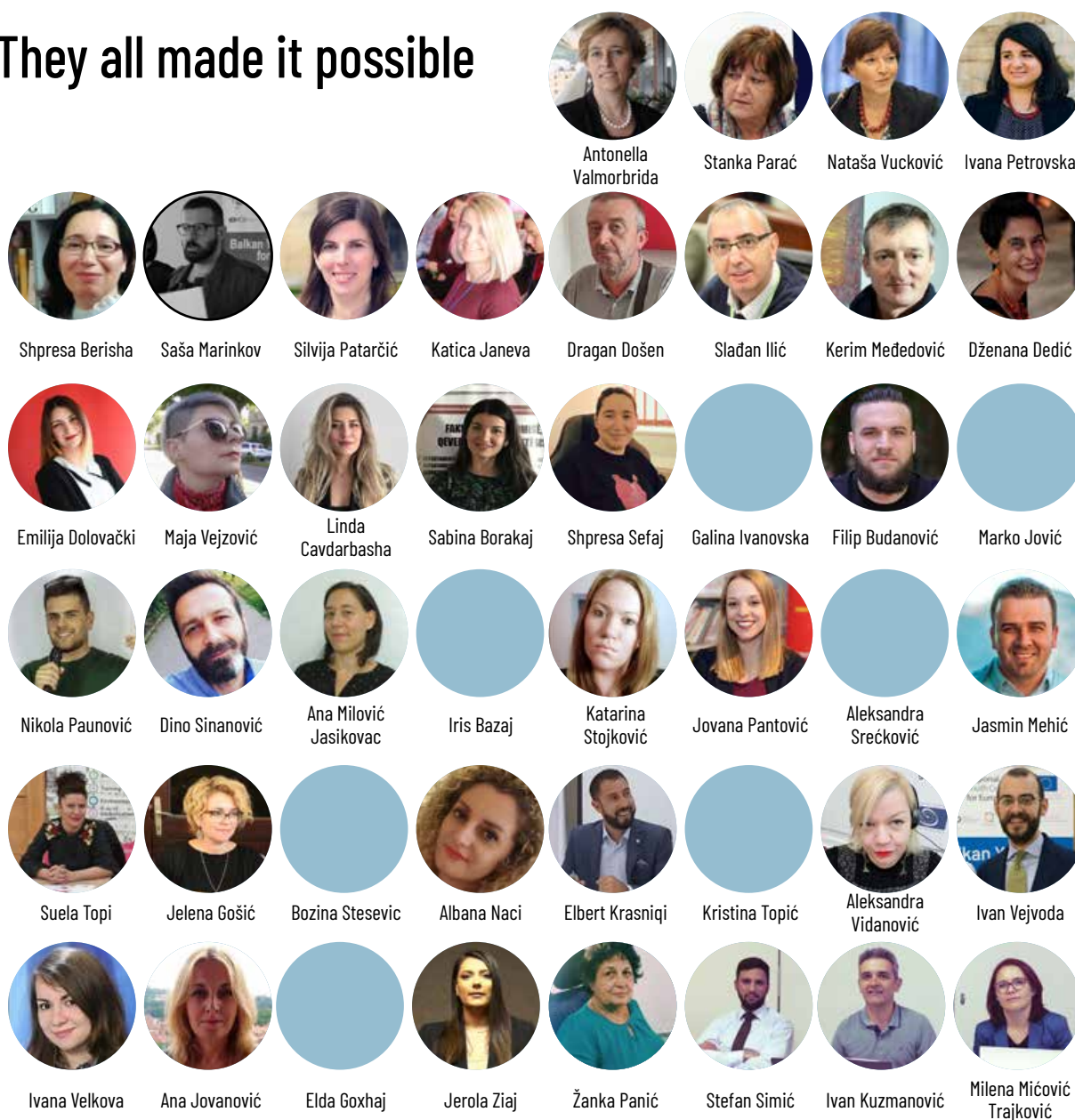

The Second Training for the members of the Network

Knjazevac, September 10-12, 2019

Organized by LDA CSS from Knjazevac, as a three-day event, this training aimed to up-grade capacity of the members of the Balkan Network for Local Democracy so as to foster participation on national level in structured dialogue with the government bodies and other stakeholders relevant for the implementation of reforms in the area of rule of law, fundamental rights, employment and public administration reform, as well as to initiate such dialogue on local level.

Study visit to the National Convention on the EU

Belgrade, November 29-30, 2018

As a follow-up to the training, the study visit, organized by the CDF, provided direct insight in the functioning of a well-developed and structured dialogue between the civil society organizations and the Government of the Republic of Serbia, concerning the accession negotiations with the European Union. The opportunity was taken to make an official presentation of the RYCE Project to media.

The introductory notes were given by **Nataša Vučković**, Secretary General of the Center for Democracy Foundation and **Nicolas Bizel**, Head of Operations Section 1, at the EU Delegation in Serbia.

1st Regional Thematic Network Forum

Tirana, February 2019

The aim of the Forum was to launch the collaborative activities engaging local and regional thematic CSO networks and youth groups to contribute effectively to the awareness raising, reporting and monitoring of the progress of the Western Balkan countries towards the EU integration. The organizers of the Forum were ALDA and Youth Act Center Albania. The Forum gathered 72 representatives of the civil sector and youth from the Western Balkans and Turkey.

- priority areas of the accession negotiation process with the EU: the rule of law, fundamental rights, social policy and employment, public administration reform;
- support to a more enabling environment for civil society and youth participation in structured policy dialogue, strengthening the capacity for reporting, monitoring and advocacy actions to promote effective implementation of the EU integration-related reforms.

Regional Forum Youth Regional Compact for Europe Network

We Will Do It Together!

Prishtina, November 2019 • Organized by LDA Kosovo

The Regional Youth Forum was designed as a youth initiative for networking and regional cooperation and was supposed to grow up on the basis of other youth-oriented activities –workshops, trainings, regional Politeia School.

The networking focused on demanding acceleration of reforms in the WB countries and reinvigoration of the EU integration process. Also, it was previewed as a platform for demanding that governments implement youth policies that would respond to youth priorities in the region – access to quality education, good jobs, open perspectives for career advancement, more mobility, more governments.

Fifty seven participants from youth organizations in the Western Balkans gathered at the Forum with the aim to establish a youth network of young students and activists for monitoring the EU related reforms within the EU integration process.

Outcome

During the Regional Forum, the young participants together with the project partners developed the Youth Platform for Regional Cooperation.

Youths from Western Balkans and Turkey listed their shared problems as high youth unemployment rates, lack of youth participation in the process of policy creation, brain drain, gender equality, their worries for the environment and rising Euroscepticism among their peers. The participants highlighted the need for regional approach in overcoming the listed problems.



Youth Platform for Regional Cooperation



We the representatives of the youth of the Western Balkans and Turkey, under the auspices of the Regional Youth Compact for Europe, have gathered to form the Youth Regional Compact for Europe Network.

In light of the shared problems we face in the high youth unemployment rates resulting from the lack of job opportunities and the difficult transition from education to the labour market. The fact that, even when youth are employed, jobs are often characterized by a high degree of precariousness and mired in insecurity. Employers often see their workforce as a resource to be exploited. There is a growing gap between the haves and have-nots making social cohesion nearly impossible to achieve. Laws do not take into account the greater good and legal processes underline a severe absence of the rule of law. Corruption has become endemic and is crippling the progress of our countries. This is compounded by the lack of youth participation in the processes of policy creation, especially on the local level where inclusion of all stakeholders is required most, and the disregard of decision makers in seriously working to overcome these challenges as well as a scarcity of inter-generational solidarity and social solidarity in general.

Consequently, the percentage of youths that are not in education, employment, or training is two times as high as in EU-28 countries, seeing no perspective in their countries of origin youth seek opportunities outside their borders. Brain drain has a debilitating effect on all aspects of society. To address it properly we must first have a dialogue between stakeholders, with a particular emphasis on youth. The core reasons of brain drain need to be identified and dealt with. Only with an inclusive dialogue on this issue can we hope to start to find an adequate solution.

Gender equality is also lacking in our countries. Gender stereotypes are widespread, as is gender discrimination in the labour market. Women still face large hurdles in breaking into politics and top management. The amount of gender-based violence is particularly worrying. There needs to be a shift in society, both from the bottom-up and from the top-down. Discrimination of any kind cannot be tolerated! In this regard we especially believe that judiciary has an important role.

Our environment and the future of our planet are at stake. Climate change is a fact that we feel more year after year, with record temperatures and an increased number of natural disasters. The energy we consume is dirty and the resources unsustainable. The air we breathe and the rivers from which we get our water are polluted. Our generation takes these problems very seriously and we call on decision-makers to do so as well. Without an intergenerational and societal approach and strong political will we cannot overcome these challenges.

We see a worrying rise in Euroscepticism among our peers, but also the advantages that EU integration can bring both as a leverage for crucial reforms in our countries aimed at curbing widespread corruption and establishing the rule of law and as driving factor in the economic and social revitalization of the region. These advantages must be better communicated to youth.

We note the need for a regional approach in overcoming the listed problems and the urgency of prevailing against intolerance propagated through short-term minded and populist political rhetoric and our sincere conviction of the necessity maintaining peace in the region and fostering intercultural cross-border exchange in order to build awareness of the fact that far more things bind us together than separate us.

Youth is crucial to the prosperity and future of the Western Balkans and Turkey we should not be ignored but instead must be embraced. Without youth there is no hope, with youth our societies can prosper and thrive!

We call on governments, academia, employers, trade unions, civil society organizations, the European Union and other international actors to lend their support in overcoming these challenges.

We commit to actively contribute to overcoming our shared challenges, both as individuals and by working within youth organizations, to propose and advocate for inclusion and reform, to hold governments accountable to youth for amending the present situation and providing a clear vision on how to achieve a future of peace and existential security.

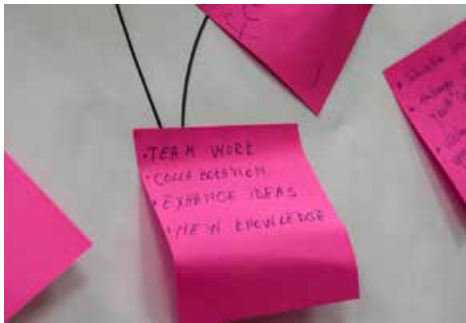

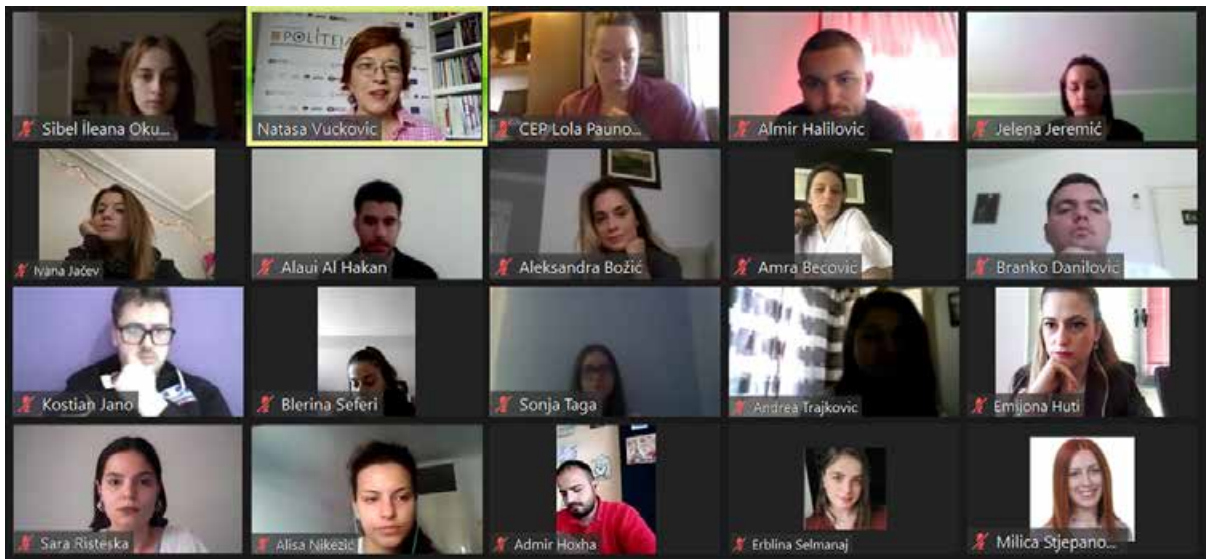

Internship program

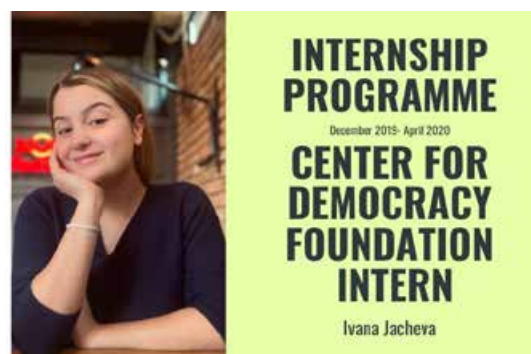
The Internship program was organized to enable youth exchange and strengthen capacities of interns for active engagement in civil society organizations.

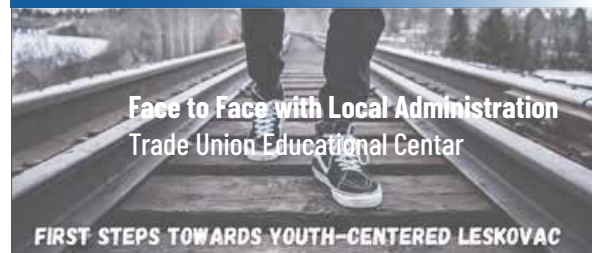

Projekat "Prvi koraci za Leskovac prilagođen mladima" podržan je od strane Evropske Unije kroz projekat "Regional Youth Compact for Europe" koji sprovodi Fondacija Centar za demokratiju.

On May 26-28, 2021 the CDF organized a two-day meeting of all grantees in Belgrade with aim to present their results.

All the projects were implemented during the COVID-19 crisis which showed capacity of small organizations to adjust to changed circumstances, keep their target groups active and motivated and deliver expected results. In general, the projects addressed the need of the youngsters to stay connected, learn in an online environment and overcome the consequences of confinement during the COVID-19 crisis.

The gathering in Belgrade was an opportunity for the grantees to meet each other and discuss potential future cooperation on the basis of their small grants results.

On the second day of the gatherings, the grantees attended the specially designed training on fund raising.

Comparative study

Civil Society Involvement in Monitoring EU Accession and EU Integration Processes in the Western Balkans – from Initial Projects to Structured Dialogue



The comparative study “Civil Society Involvement in Monitoring EU Accession and EU Integration Processes in the Western Balkans – from Initial Projects to Structured Dialogue” was conducted by CRTA and published in November 2019 in Albanian, Macedonian, Serbian and English language.

The study aimed to identify practices and potential of civil society to participate and contribute to decision making and in a dialogue regarding the reforms relevant to the EU accession processes. The study was divided into two parts. The first part covers Montenegro and Serbia, which have already started accession negotiations with the EU, while the second covers Albania, Bosnia and Herzegovina, Kosovo* and North Macedonia which are not yet in that phase of EU integration.

Research focus

Civic involvement and monitoring in specific areas covered by [Chapter 19](#) – Social Policy and Employment, [Chapter 23](#) – Judiciary and Fundamental Rights and [Chapter 24](#) – Justice, Freedom, and Security, as the most challenging and most demanding chapters in the integration process.

Key directions for improvement and recommendations included

- Open, positive and constructive dialogue between state and civil society organizations is essential;
- Further steps to improve the legislative framework for civil sector participation is needed;
- Ideas and recommendations coming from the civil society should be evaluated in a meaningful way;
- Strengthening CSOs capacity and network building to influence public policy is required.

Key regional issues identified

An improved framework for the CSOs participation does not necessarily mean a constructive dialogue between the government and civil society, better legislation and greater influence of CSOs;

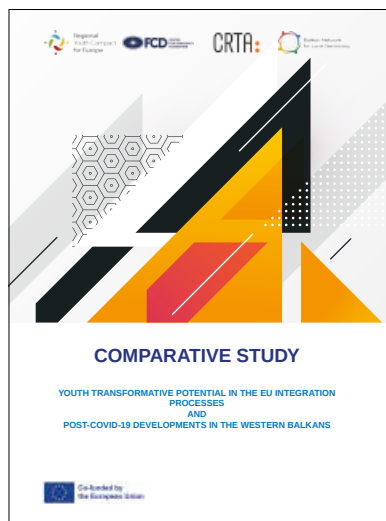
The number of proposed recommendations and suggestions given by CSOs during the consultation phase of the adoption of laws and strategic documents that are incorporated in the final versions remains extremely limited;

There is still a limited number of CSOs that participate in decision-making especially at the local level;

Transparency of the European integration/negotiation process remains limited.

Comparative study

Youth transformative potential in the EU integration processes and post-COVID-19 developments in the Western Balkans



This research study, again prepared by project partner CRTA and published in 2021, tried to identify what are the transformational potentials of WB6 youth in the EU integration processes and where do these potentials reside, particularly in the light of the COVID-19 crisis. More precisely, the study wanted to investigate and analyze the key drivers and motivation for youth participation in decision-making processes, and the relationship between that motivation and the perspectives in relation to the EU and its core values.

The study also attempted to give indications of what makes the youth adhere to those values in 2020, having in mind political and social turbulent dynamics in the region, as well as what motivates them to move forward and stay actively involved in their societies and the region's future. The study particularly examined how COVID-19 crisis affects their motivation and perceptions, as well as how youth perceive the effects of the pandemic on their further

involvement in the policy designs and the EU integration processes. It analyzed what tools and approaches, when it comes to youth participation, work best, and which ones are expected to be more efficient and fruitful in the future.

Research methodology

1. Focus group interviews (FG), a method of qualitative research, which allowed for deeper understanding of behavior, attitudes, motives, and practices.

A total of 12 FGs were conducted, 2 in each of the targeted societies, during June and July 2020. The target group was the regional youth, from 18 to 30 years old, with dominantly neutral to positive perception of the EU and with the experience of and/or knowledge about the participation in the decision making, policy design and/or monitoring processes on local or national level. This FG composition allowed for deeper insights and knowledge of youth participation from those who know how the participation process looks like, what are its (wanted and unwanted) outcomes, and, as the study has showed, how closely connected it is with activism. FGs consisted of 6 to 8 participants (6.3 on average), which allowed for active contribution of each participant and for the lively group dynamic. All FGs were conducted electronically, using Zoom platform. They were recorded (audio and video), and transcribed (and translated where needed). FGs lasted approximately for 120 minutes, which was more than anticipated.

2. Desk research work was conducted during July-September 2020. The data was collected through the review of the official legislation, previous analysis and research conducted by national and local youth CSOs, international organizations, umbrella organizations, research institutes and other institutions involved and interested in the issue.

Preparations, selection of FG participants, FG interviews and the analysis itself were taking place during the COVID-19 pandemic. This affected the study-making process, both technically and thematically. The focus group meetings were organized at the time when the first wave of COVID-19 has just passed and the second one was on its way,

with the local outbreaks happening across the region and with an anticipation that the next wave would happen in autumn. This situation has significantly affected the respondents' assessment of their own reactions and the local and national governments' response, as well as their perception of youth reaction to this unprecedented situation. It was difficult for participants to give any predictions about how the COVID-19 experience would affect the future of youth participation because nobody knew at the time how exactly the pandemic would further develop, not to mention how long it would last.

Key findings

Selected key findings should provide more understanding of the social and political context in which the WB youth resides, as well as the most important insights important for understanding the potentials and limitations of youth participation in the region.

- A strong migration drive is one of the most outstanding commonalities of entire WB region, and a large number of young people are thinking about leaving to other countries outside the region, primarily because of unsatisfying socio-economic conditions;
- General understanding of participation among interviewed youth activists includes a range of different perceptions: both as a formal and informal activity, done through formal or informal channels. Participation is also closely connected to activism itself, here defined as taking a public stand and engaging in an activity to tackle a publicly important issue;
- Low level of trust in the institutions and the elites makes informal participation tools and mechanisms more attractive. These mechanisms and tools have a more powerful democratic potential, bear more energy, and allow for more creativity, but sometimes are less efficient and less credible in the formal systems where decisions are made;
- The COVID-19 crisis, as well as any other potential crisis, is seen as both an opportunity and a threat. In other words, in the Western Balkan context, the pandemic is perceived as something that can bring the best out of young people – solidarity, motivation and creativity, and the worst out of autocratic, populist regimes.



In preparation of the study, a young respondent to survey questions said:

“ I would like for young people in the Western Balkans to be more connected, to exchange experiences and knowledge more. That is very important because young people in the Western Balkans, unfortunately, do not know enough about each other. The tragic '90s took us apart. We have a lot of common concerns and problems that we can solve together or at least help make the positive change happen. ”

Advocacy

Promoting EU Integration of the Western Balkans, fostering dialogue among key stakeholders for reforming the quality of life and the capacity of the state to deliver on democracy, rule of law and human rights and motivating citizens to participate in policy debates on local level was in the core of our advocacy activities.

- Through regional conferences we reached out to national governments, international organizations, policy makers, local governments, civil society organizations and businesses.
- Through multi stakeholders' platforms representatives of local authorities were involved in public dialogue with citizens, business sector and CSOs.
- Open assemblies provided platform for citizens to speak out, meet their representatives in local governments, place their requests and search for support.

Advocacy on regional and national level through regional conferences

Every year a regional conference gathered decision makers, scholars and civil society activists to discuss the status of EU integration of the Western Balkans and to reiterate the role of the civil society in the process. Democracy, rule of law and fundamental rights as well as fight against corruption continuously were the topics of the utmost concern. In addition, we focused on social dimension of the reform process, particularly on social policy and employment, as well as education which are all the highest concerns for the young generation in the Western Balkans.

The first regional conference was organized in Tirana in February 2019. The COVID-19 crisis postponed the second annual conference which, initially planned for end March 2020, took place in Novi Sad in spring 2021 as a hybrid event. The final one was organized in Belgrade as a hybrid event, but with in vivo participation of project partners – an occasion to see each other after more than a year!

The first annual conference

Tirana, February 27, 2019 • Organized by ALDA and Youth Act

Total 72 participants from Albania, Bosnia and Herzegovina, Kosovo*, Montenegro, North Macedonia and Serbia took part in the Conference which gathered high ranking representatives of relevant institutions, development agencies and CSOs, representatives of local and regional stakeholders and students.

Recommendations Resulting from the Conference

European Union and the Western Balkans: Towards Renewed Trust
held in Belgrade, 1 July 2021, under the Regional Youth Compact for Europe project



Civil Society Organisations (CSOs) - partners of the Regional Youth Compact for Europe project which over the last three-year period has promoted the process of Western Balkan integration into the EU, brought together and encouraged regional youths toward activism and supporting reforms on the path toward the EU and strengthened the capacities of CSOs in local communities to dialogue with decision makers and the citizenry on the subject of developmental policies. At today's conference, EU and the Western Balkans - Towards Renewed Trust the partners agreed to send the following messages to key actors:

We urge the governments of Western Balkan states to hasten reforms in these areas, in particular, rule of law, democracy and combatting corruption, ensuring the consistent application of EU standards in the areas of public procurement, infrastructural investment and development, and to make environmental protection a political and developmental priority.

We call upon these governments and decision makers to improve the manner in which they present EU contribution to economic and social development to the public as well as the benefits which development and the EU integration process bring to the population, at the regional, national and local levels, and to represent EU membership as a priority strategic foreign policy.

We ask the governments of Western Balkan states to apply the principles of the European Pillar of Social Rights in planning public policies and in monitoring reforms, and thus strengthen the social aspect of EU integration, which is of key significance to maintaining and intensifying the support of the public in this process.

We call upon both our government and the EU to include Western Balkan youths in considering development policies and encouraging them to apply European values through educational, cultural and regional collaboration.

We consider it important that the Western Balkans are included in the Conference on the Future of Europe.

We invite the EU to open accession negotiations with Northern Macedonia and Albania by year-end 2021.

We invite the EU and countries of the Western Balkans to continue to develop solidarity in resolving their mutual issues and crises management. We also expect solidarity from regional EU member states on our path toward EU integration.

We believe it a necessity that all participants in the political sphere work toward improving the quality of political dialogue, parliamentary democracy, the participation of the citizenry and freedom of the press.



Advocacy on local level

- Multi-stakeholders` platforms were established by partners in local communities engaging CSOs and youth organizations in dialogue with local government, public and private sector.
- In direct actions with citizens the awareness was raised about the benefits of CSOs and youth involvement in EU integration processes.
- Through My City - Youth City, open Local Assemblies initiative - youth participation in decision making processes on local level was encouraged and promoted.



Visibility and Outreach



Communication was our key activity. In 2018 we developed and adopted the Communication strategy. Communication and visibility framework of the project was upgraded with the adoption of the Digital Marketing Strategy: Regional Youth Compact for Europe 2019-2021.
