## → Theme: Roles and responsibilities of migrants' inclusion in the labour market

Talking about "inclusion", the responsibility lies not just on stakeholder, but several key actors of the community are called to dialogue and collaborate. Let's talk about how a cluster network can be created with 3 concrete key stakeholders active in the inclusion of migrants: with the civil society organizations and with the migrants, LIME project; with the private sector, speaker from the private enterprise; and with the institutional sector, speaker from the Municipality/public service.

During the panel, the speakers will share their different perspectives from their experiences in migrants labour inclusion.

**LIME – Labour Integration For Migrants Employment** – is a 2-years project which aims at promoting the **swift integration of young Third Country Nationals** – TCNs – (aged 18-29) in the labour market, by implementing the *Migrants Economic Integration Cluster* – **MEIC model** all over Europe.

LIME project is funded by the European Union – DG Home Affairs – Asylum, Migration and Integration Fund (AMIF), and it gathers 7 partners from Italy, France and Spain:

The LIME project core action is the MEIC methodology. The *Migrants Economic Integration Cluster – MEIC* methodology is an innovative and participatory approach based on the creation of a partnership of socio-economic multi-stakeholders, including public and private actors.

The LIME project produces a <u>comic</u> whose purpose is to raise awareness on the issue of labour inclusion of migrants by sharing the story of a refugee/migrant person who arrives to Europe. The comic represents how the life of the protagonist has changed thanks to the collaboration and the support of different kind of stakeholders.

The comic can teach us how the process of integration can be difficult, and the importance and added value of people like that in our society.

The main target of the comic are: young people, civil society organisations, universities and students, educators, employers' associations, vocational training providers, employment services, as well as migrants and refugees to know some successful stories to inspire them and know that it is possible.
