President's Foreword

ALDA Walking the Talk

Dear Readers,

it is an honour and pleasure for me to introduce once again the annual report about the activities of the Association of Local Democracy Agencies and of the individual Local Democracy Agencies. Throughout 2011 ALDA has continued to consolidate its position as a widely recognised promoter of local democracy, fundamental rights and civic participation across the European Continent.

The Euro-crisis and the many doomsday prophecies associated with it have diverted the attention of many – too many - from the true meaning of a united Europe. However, against the background of the media noise one should not forget what the European Union has meant for peace and prosperity in Europe over the last 60 years. That is what is important! The EU's efforts will surely continue and so will those of ALDA in promoting democracy, respect for human

and minority rights and the rule of law.

True to this commitment ALDA has in 2011 continued enlarging the LDA network. In October we opened the 13th LDA in Gyumri in Armenia, which is twinned with Kutaisi, the host city of LDA Georgia, and all the practical aspects are being sorted out so that the LDA should be fully operational in early 2012. Establishing a LDA Azerbaijan is next on ALDA's radar screen and the process to reach that goal has been initiated. The reorganised LDA Kosovo in Peja/Pec has been confirmed in its existence and is also fully operational since November.

I cannot but welcome the fact that the Republic of Croatia has been accepted to become the next member of the EU, signing the Accession Agreement in December, and confirmed by the population at a referendum in January 2012. The consequences for the three LDAs in Croatia once membership takes effect from July 2013 have been under consideration by the Governing Board and the LDAs for a while. Suffice it to say at this juncture that the extensive experience accumulated by these three LDAs will be fully exploited for the benefit of our network also in the future.

In addition, ALDA has been closely associated with the EU's Eastern Partnership and we are working directly with non-state-actors in Belarus to push for much needed democratisation of that country. This reflects our long-standing challenge from the Balkans: On the one hand you have ordinary citizens who based on past developments are suspicious of democratisation and on the other hand you have die-hard politicians who fear democratisation which will rob them of their power base. Helping to build functioning states requires a good deal of patience!


Our conviction that "walking the talk" is so much better than just "talking the talk" has resulted in a wide panoply of projects in 2011: On active citizenship we have been nothing but active. ALDA's General Assembly was held in Bydgoszcz, Poland, in conjunction with a well attended conference on

Volunteering; a project called Stand-Up has been promoting cooperation between local authorities and civil society from Latvia to Malta in facing the negative consequences of the financial crisis; and yet another has been addressing the issue of Remembrance as a means to preserve a peaceful future for Europe. You will find many more details about these and other projects in this report, which clearly show that democracy is not a spectator sport.

The coming years will be extraordinarily important for ALDA's long term development. Apart from our normal activities we will become more engaged with partners in the Mediterranean Region and try to offer our support and experience in assisting the civil society involved in the Arab Spring. To that end we have established a number of alliances with organisations having objectives similar to ours but we also expect to rely on continuing good cooperation with European Institutions and partners.

In conclusion, I would like to thank the entire ALDA and LDA staff for their contributions to our achievements this past year, our donors and partners for their collaboration and our members for their confidence and unfailing support.

I wish you an interesting read of this – once again – excellent report.


We look ahead for 2012 and 2013 (which might be soon confirmed as the European Year for Citizens) to be stronger and bring results and outcome.

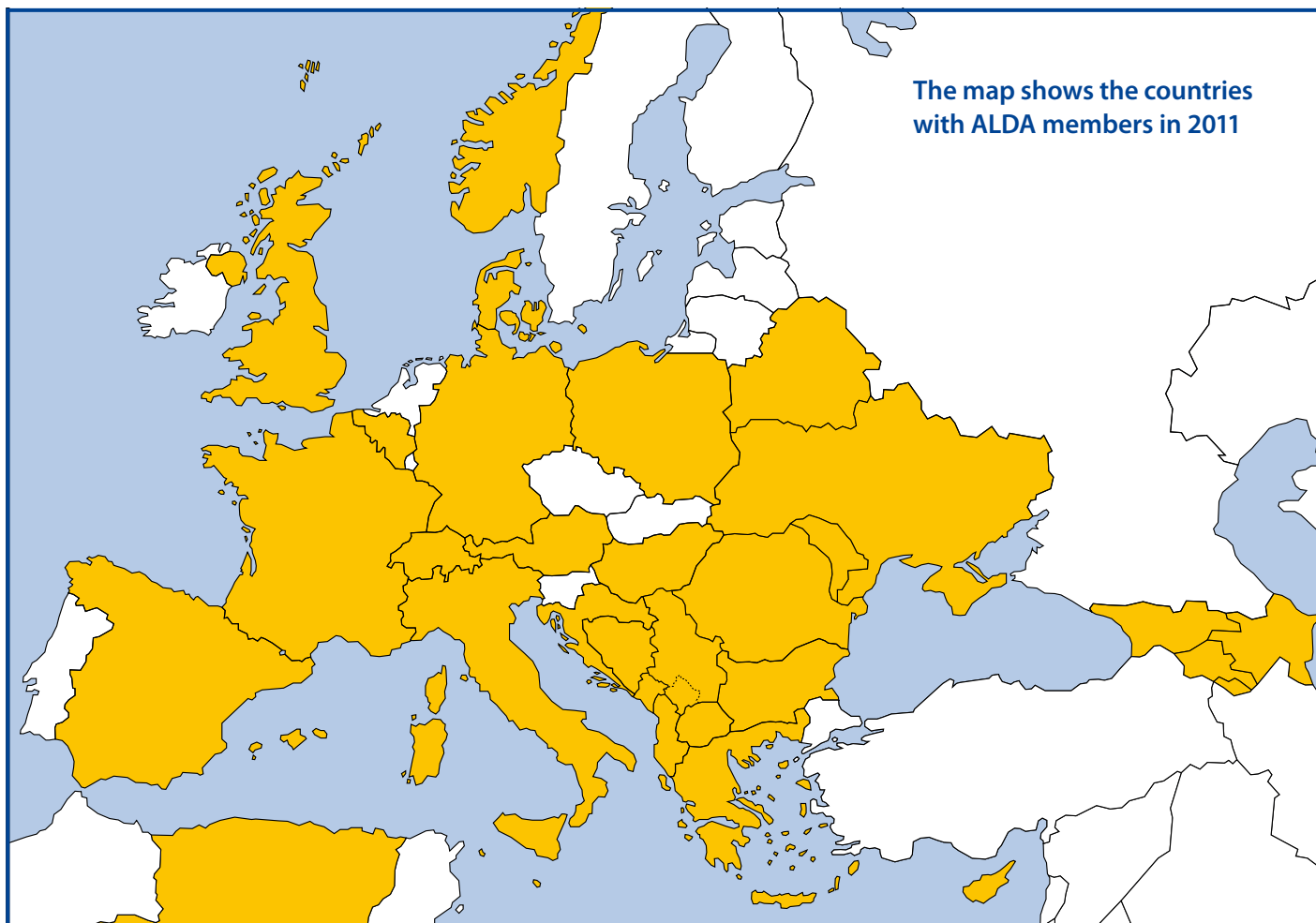
All our team, staff and Local Democracy Agencies, confirmed their strong commitment in the mandate of ALDA, at the service of our members!

1. Strategies, goals and partners in 2011

In 2011, ALDA further developed the main strategies decided in its Position Paper in 2009, namely the support to the Local Democracy Agencies, the enlargement of the network in Southern Caucasus. We worked extensively with our members to promote Citizens' participation, local democracy and a wide debate on the present and future of Europe. A special attention was dedicated to the activities giving full support to the European Year on Volunteering.

Citizens' participation, European Year on Volunteering and Local Democracy

In particular, thanks to the supporting programme Europe for Citizens, ALDA developed many projects and activities to strengthen the common sense of European identity, with our LDAs and with our members. We developed programmes for supporting the innovative forms of twinning between municipalities, the full involvement of civil society in Eu-

ropean policies and a shared remembrance of the past with our programme PEACE. The debate on the present and future Europe, heavily affected by the economic crisis, was open with our members through debates all over Europe and in the future Europe, like in Croatia and in South East Europe.

ALDA was active part of the Alliance for the Year on Volunteering and dedicated its annual conference to the topics.

Many activities on new forms of volunteering were presented during activities.

A strong lobbying has been realized in 2011 in order to promote the opening of the programme Europe for Citizens for all the countries of South Eastern Europe. This might have results already visible in 2012. ALDA became, even more, a support for its members – with trainings, dissemination activities and conferences – to get acquainted to the different programmes of Active Citizenship.

Development of our strategy in South Eastern Europe in their way to the accession to the European Union. Support to LDAs and strengthening of the office in Skopje

ALDA and the LDAs have been playing a major role in South Eastern Europe in these last 10 years, through a process of peace consolidation and relaunch of communities and dialogue between civil society and local authorities. Last year ALDA and the LDAs worked even stronger to promote local democracy, youth and civil society empowerment with a set of activities supported by the European Commission – and the Instrument for PreAccession – and by the programme Europe for Citizens (eligible countries Albania, Macedonia and Croatia).

Decentralisation, good governance and citizens' participation are today essential elements for the stabilisation and development of the area of South Eastern Europe.

The LDAs focused on strengthening the capacities of the Local Authorities to address the local needs and also to further engage citizens in the decision making process at the local level. In July 2013, Croatia will complete its accession to the European Union and this represents a great satisfaction for our network.

Thanks to the work on local governance and promotion of decentralisation of the programme Lower Normandie/ Macedonia, ALDA has consolidated the presence of its office in Skopje with the opening of its own office.

Experience of decentralised cooperation, local democracy and citizens' participation

In 2011, ALDA further consolidated its partnership with members and stakeholders. In particular, the organisation tried – with success - to develop activities where the methodology of citizens' cooperation showed results for good governance and improved services to citizens, relaunch of development and inclusive communities. Our experience has been brought to the attention of various networks and institutions.

The experiences were therefore studied with projects and integrated into Position papers and various consultations, where ALDA could be considered a major point of reference in this field.



ALDA joined the network of CONCORD, a consortium of European NGOs focusing on Policies for Development. A particular work with them is undertaken so that to address the future Agenda for Change in the field of Development, which will be following up the Structured Dialogue on Development of the EC, our intention being to include the dimension of work between civil society and local authorities in the development policies.

Eastern Partnership and Southern Caucasus

ALDA was focused and engaged in Eastern Partnership countries and in particular Southern Caucasus in 2011. Our Director was appointed co-Chair of the Civil Society Forum for Eastern Partnership from January to November 2011 and actively participated to enlarge its influence in the decision making process at European level. Our mandate in the area is the support of civil society and local authorities and local governance. ALDA focused also on supporting its activities for empowerment of civil society in Belarus. www.eap-csf.eu

In Southern Caucasus, our focus was to develop and strengthen the LDA in Georgia as well as setting up the LDA Armenia, based in Gyumri. The opening was celebrated in October 2011. This opens further possibilities to be engaged at the regional level.

Our activities in Southern Caucasus are implemented closely with the Congress of Local and Regional Authorities of the Council of Europe.

Approach to Med area

With new projects in Algeria and Tunisia in 2010, the past year further developed ideas of cooperation in the Med area, also in coincidence with the recent "Arab spring".

The role of local authorities and decentralised activities, with the support of civil society, is certainly one of the most important progress to make in this area. In 2011, we have therefore concluded some of our activities and initiated new contacts and partnership, which will hope will be also continued in 2012. Our strategy in the area is to use our expertise and role of LDAs as for the democratic transition in Med region.

Engaged in Development

The partnership between local authorities and civil society, in policy making and projects implementation, represents a fundamental asset for development. We have experienced it through the long lasting presence of the Local Democracy Agencies but also in many activities run under the programme Europe for Citizens, in Europe. The evolution of the concept of Decentralised Cooperation and the new programme for Non State Actors are giving ALDA the opportunity to apply most of its already experienced best practices, in a challenging field, Development and international cooperation.

With the programme WTD (Working Together for Development), ALDA is launching an Alliance (started in 2011 and continuing in 2012) between local authorities and civil societies, which will give us the opportunity to strengthen capacities of our partners and members and propose new solution for Aid effectiveness.

A membership oriented organisation

Considering the difficulties that our members (local authorities and civil society organisations) have faced in 2011, ALDA dedicated even more energy to support its services to them. We offered support in lobbying towards European institutions and policy making processes as well as frequent projects and call for proposal to join.

Our members are ALDA's main partners in projects both in the EU and in the Neighbouring countries, interested in sharing and gaining experience in local governance and citizens' participation.

ALDA supported the members also with specific assistance and with the premises in Vicenza, Strasbourg and Brussels. It provided members also with support for partnership and European contacts for their own policy making. Despite some of our members left the organisation, becau-

4. Capacity building activities for LDAs and ALDA

ALDA strengthens the capacities of the Local Democracy Agencies and its own staff in order to implement with better efficiency and impact the mandate of our Association. The task is demanding (in energy and financial resources) because the LDAs and the ALDA staff are located in different countries.

The first training and networking meeting took place in Subotica (Serbia) on the 25th and 29th of January 2011. The ALDA staff and the LDAs participated in a training session, and exchanges, as for the project implementation (programmes, synergies, funding reporting, networking, etc). A special session was dedicated to financial issues. Another session was dedicated to visibility and communication of our activities.

Other staff meetings and training activities for senior and junior staff of ALDA took place on the 23rd of March and

21st of September 2011.

A specific capacity building session took place in November 3rd to 5th 2011, with the celebration of the 15th anniversary of the LDA Sisak. The Delegates focused on the main strategic elements for their work in particular for the coordination of common activities.

Other issues:

- Joint communication strategy: how to promote the LDAs in ALDA network and outside the network - seeking innovative, prompt and efficient solutions for improved visibility of each LDA.
- Strengthening the partnership of LDAs: developing a new concept of partnership to meet Local Authorities needs and to face the economic crisis. Definition of a new concept to be presented to ALDA's Governing Board and to the Partner Leaders.
- Brainstorming on Local Economic Development. Joint discussion to define a common perspective for a possible further engagement of LDAs in this direction.
- Croatian entering EU: the future of Croatian LDAs. Open discussion of the future role of LDAs in the EU.

7. Media and communication strategy

Communication is the key tool for ALDA to undertake its mission of disseminating European values, promoting active citizenship and facilitating cooperation among local authorities and civil society. In 2011 ALDA focused its efforts on its website, renovating it and making it always updated with news, and documents released throughout the world and strengthening international relations. For many people, especially the young, the Web is the best way to access information. It is also the way many potential supporters begin their investigations of a mission-based organization they are thinking to work with.

Potential partners, press people, politicians and European officers who look for in-depth information usually surf through Internet websites. Indeed, the core of an organization's online presence is its Web site! Secondly, in 2011 ALDA worked on a new attractive layout of its Newsletter, which reaches over than 12 thousands of people.

Last, but not least, ALDA launched and reorganized its press office, keeping to promote its work among international and local media, communicating its initiatives, projects, priorities to journalists accredited at the European institutions and at local level. Print media, television networks and information on the web are the channels through which ALDA complete the dissemination of its activities.

The community theater is designed and developed by a team with various competencies in the theater and social-cultural field and a high experience within communication, complex relations and symbolic reconstruction of reality.

The Caravan will make almost 40 stops in 11 countries in Europe, including Western Balkans, staging more than 50 performances completely free to the public. The shows will take place in public places (outside of historic houses, squares, schools, hospitals, railway stations) in order to involve the local population, and in this way help promote participation and confidence building in multicultural communities.

Purposes

The project tackles the issues of strengthening democratic institutions and local administrations to consolidate the role and the capacities of the municipalities, as actors of development and promoters of local participation.

The Municipality of Thiene intends to promote a cooperation plan with the Municipality of Ijevan in Armenia, focused on citizens' participation and the role of the local authority in promoting the development of the municipality.

General objectives: To develop a decentralized cooperation path with the Municipality of Ijevan (Armenia) able to evolve to a long-lasting relationship on which building up project initiatives in several fields; To contribute to the strengthening of the local authority's role in the participative policies and practices, through the exchange of experiences and the establishment of an equal relationship between the municipalities involved, following the typical methodology of the "twinning"; To promote the participative development of the city, through the active involvement and the establishment of a constructive relationship among the local stakeholders.

Purposes

Promote civil dialogue in local communities in Bosnia Herzegovina and establish sustainable mechanisms of public consultation through effective implementation of municipal co-operation memorandums.

Activities

Purposes

Joint effort of the two partner entities to open up to the world and to encourage their population to engage in active citizenship at local and European levels by reciprocity and exchange.

Activities

The project aims to facilitate both territories mainly through the activities in 6 different components: Digital technologies; Youth, local and European citizenship; Inventory of cultural heritage; Regional cultural policies; Tourism; Agriculture development. The core of the programme is implementing activities in tandem with non-governmental organisations, under the auspices of the Macedonian Ministry of Local Self-governance and the Regional Council of Lower Normandy. They run this programme by leveraging support and interest in the local communities, involving ci-

tizens and organisations at various levels: public institutions, NGOs, professional bodies, such as Chamber of Commerce, the media as well as other relevant parties.

Having that structure in mind, the activities of this fifth year of cooperation are introducing innovations and reinforcement in all six components, such as reinventing of the component of tourism or establishing the new component of human rights. The project also encourages the equitable regional development process in Macedonia and European integration in both territories.

Twinning is also strengthened this fifth year of the cooperation and so far seven municipalities from the two territories are working closely. Their cooperation continues with exchange of best practices in several fields such as tourism, youth and culture. Working groups are created in both territories in order to promote the common approach towards international cooperation both in Macedonia and in Lower Normandy.

Marching towards equitable regional development in Macedonia, Lower Normandy and Macedonia are offering their institutional support, experience and training.

The mutual work and exchange will continue to build stronger international relations, dynamic environments and active citizenship towards democracy and friendship.

Successes Stories

The Programme for decentralised cooperation between the Region Lower Normandy and Republic of Macedonia is constantly showing the commitment of both territories in developing opportunities for international cooperation while promoting the local governance by reinforcement of local authorities' capacities to implement decentralisation.

The international perspective, in the form of decentralised cooperation between the European region (Lower Normandy) and a Balkan Republic (Macedonia) has produced a decisive increase in the presence of local governments and the associations on the international scene of global sustainable development.

Purposes

The project “Network for Community Development with Marginalised Social Groups”, part of the Lifelong Learning Programme - GRUNDTVIG – Learning Partnership, aims at facilitating the mutual learning of innovative tools of community development that tackle the problems of marginalized social groups. The main aim of the project will be sharing knowledge and experiences gained from experimental, innovative, interdisciplinary community based methods effective in combating poverty.

The aim is to bring methodological innovation cutting across professional boundaries, combining elements of community development and social work, to introduce new approaches of development in seriously marginalized, deprived, often ghettoized localities, facilitating progress that does not only bring anti-poverty measures but also social integration.

The partnership brings together organisations that deal with similar social issues and different methodologies of community development. The cooperation can lead to long-term work based on learning about the different national contexts,

methodological approaches and adaptable, good practices. The project will be based, in a large extent, on collecting valuable experiences by fieldwork, by visiting projects dealing with community development of marginalised groups.

Activities

Workshops and learning exchanges with the partner organisations at three different localities with different problems, showing alternative approaches of community building, took place in Strasbourg, Glasgow, Barcelona and Budapest.

Implemented so far:

- Workshop on multilateral decentralized cooperation and community development, introducing participants to ALDA's networking methodology, to the concrete experience of the Municipality of Strasbourg.
- Workshop on methodologies of citizens' empowerment, participatory and community work (field visit in Scotland).

8.11 Long term training course “Let’s train with our neighbours: civil society, participation, democracy”

Purposes

The aim of this long term training course is two-fold: on one hand, it aims at promoting reflection, debate, exchange and action on democracy and participation issues and, on the other hand, it seeks to support the development of qualitative youth cooperation and networking on the specific issues addressed. The training course presents an innovative perspective of democracy in the European Neighbouring Policy Initiative (ENPI) area, starting from participants’ experiences, offering them tools and coaching during the whole project.

Activities

The training course is based on a “learning by doing” approach and divided on 3 different steps:

- 1st step: Training course – Franceville Merville (France), 5-12 October 2010
- 2nd step: Coaching Phase – from October 2010 (after the training course) to the evaluation phase in October 2011
- 3rd step: Evaluation Phase of all the “Let’s Train” – Warsaw (Poland), 6-12 October 2011

The evaluation was based on the “tree analogy” methodology, which gave to the participants the opportunity to reflect, discuss and exchange on three different levels, sharing their experiences, projects, outcomes and feelings:

- **personal level** on the basis of the key words: personal growth, learning achievements, youth pass key competencies, content knowledge;
- **process** on the basis of the key words: direction, training, projects, coaching;
- **products** on the basis of the key words: outcomes, achievements, results.

During 2011 ALDA took initial steps and started to build support for the establishment of an LDA in Azerbaijan. ALDA held two meetings with the Representation of Azerbaijan at the Council of Europe to explain the objectives and idea of an LDA in Azerbaijan, including a meeting with the Ambassador Mr. Arif Mammadov.

Furthermore ALDA, with the support of the Congress of Local and Regional Authorities, organised a Seminar on best practice for Strengthening local government and good governance at the local level in Azerbaijan and also discussed the idea of an LDA in Azerbaijan.

ALDA also strengthened its cooperation with other actors in Azerbaijan and in particular worked closely with BINA – the NGO Alliance for Municipality Development, which publishes yearly monitoring reports on the development of local democracy in Azerbaijan.

NGOs from Azerbaijan became members of ALDA during 2011, which also increased ALDA's activities and focus on Azerbaijan.

These steps taken in 2011 supported the preparations of the potential partners' meeting for LDA Azerbaijan that ALDA will organise in March 2012 to gather potential partners for the LDA and discuss the possibilities for opening an LDA in Azerbaijan. This meeting will take place in connection with the Congress of Local and Regional Authorities plenary spring session.

Purposes

The overall goal of PEACE is the creation of a network of structures working on Peace Education, Citizenship and Human rights with the intent of using the 20th Century European History as a tool for Active Remembrance.

Activities

The project PEACE was structured in 6 local events organized by partners and one international conference. Partners involved different groups of the local population and professionals at local level on the following subjects for: teaching Peace, review History with participants and understand how can partners' theoretical methods improve from these field's experiences.

Successes Stories

The Local Democracy Agencies in Sisak and Osijek were involved in the project PEACE. They respectively organised, together with the Memorial in Janesovac, an interactive

workshop on the history of the Croatian Ustasha regime during the Second World War and a seminar on civil courage, taking German resistant priest Dietrich Bonhoeffer as departure point for a discussion on the role of civil courage in Croatia and beyond.

These events succeeded in involving the different types of target groups (peace educators, students, university teachers) and in confronting participants with views on historical events that do not correspond to their usual perceptions, and thus led to question their biased views.

The partners decided to continue cooperation. Many of them are interested in joining the project THIEC on the treatment of painful pasts in school education. A joint project could give way to a more intense cooperation between different types of providers of historical education.

The Kutaisi II Conference with Local Authorities Associations and civil society organisations from South Caucasus was held in Kutaisi, Georgia in November 2010. Seminars were held in each of the three South Caucasus countries during spring 2011 aiming at discussing the strengthening of local government and good governance at the local level and methods to increase citizens participation and cooperation with civil society. The seminars in Armenia and Azerbaijan were also used to support the establishment of LDAs in Armenia and in Azerbaijan by intensifying and consolidating new and existing partnerships in the two countries.

Successes Stories

The project strengthened the cooperation between the Associations of Municipalities in South Caucasus by gathering them for the conference in Kutaisi, which allowed them to discuss common challenges and exchange information on the situation in their respective countries.

It was significant to gather the associations from all three countries in South Caucasus in order to discuss and exchange views on development of local democracy and the situation in their countries. The conference in Kutaisi and all three national seminars included detailed discussions on the question of cooperation between Local Authorities and civil society and examples of good practice from other countries.

Activities

Community groups will participate in trainings and receive information on the role played by local authorities and the possibilities for citizens and civil society organisations to cooperate more actively with them. Furthermore the project will provide sub-grants to around ten civic community initiatives.

These grants will be awarded to community groups that propose concrete activities to ensure sustainable development in cooperation with local authorities. Two of these initiatives will be partnership projects and will involve cooperation with local authorities from other countries, which will bring their experience on cooperation with citizens into the project.

Successes Stories

So far the TANDEM project has been successful in mobilising civil society organisations and local authorities from all over Belarus to apply for sub-grants. 10 projects have been selected to receive funding under TANDEM.

The project of a bicyclist organisation in Minsk intends to improve the quality of bike paths in the Belarusian Capital. The Association of Gomel children and young people (ASDEMO) will create, in cooperation with the local authorities, a leisure place for young people in Gomel's district number 19.

The Information and Regional Studies Center at Golshanskaya Rural Library District Oshmyany in Northwestern Belarus will set up a virtual museum of the Struve Geodetic Arc, a chain of commemorative plaques and obelisks, which were built along the meridian line from Norway to Moldova in the 19th century. The project will be implemented with the support of the Latvian municipality Gulbene.

The selected projects have now started the rather complicated registration process in Belarus, which is necessary in order to be allowed to receive financial support from international donors.

It was the launching event of the first Polish Presidency of the EU for Kujawy and Pomerania Region. It was attended by 150 representatives from civil society groups and local governments from all over Europe. Representatives of several European Ngo's and Institutions illustrated the experiences of their organisations and countries.

The project VIT focuses on volunteering and democracy in the enlarged Europe. It aims at promoting volunteering in towns, addressing this issue from a participatory perspective.

Purposes

Local Authorities are regularly confronted with environmental issues, which have a direct impact on people's well-being and on citizens' everyday life. Municipalities, the closest entities to citizens, are therefore evermore engaged in the implementation of environmental policies, adopted both at a national and European level. The proposal, encouraging dialogue and exchange of best practices in a long-term perspective, aims at tackling the issue of water management.

Water is the the "file rouge" of the initiative. The project aims at promoting reflection, debate and action around the topic of "water", focusing on its sustainable management. The action seeks to have a multiplier effect in Europe, leading to the setting up of a thematic network of twinned towns.

Activities

The action plan foresees 3 major events, focused on 3 different dimensions of water:

- 1. Water, a cultural value** (Sacile, Brugnera and Porcia, IT), May 2011
- 2. Water, an economic agent** (Berettyòùjfalu, HU), October 2011
- 3. Water, a territorial partner** (Novigrad-Cittanova, HR), foreseen in March 2012

The main objective of the events is to increase the citizens' awareness of the need of a sustainable use of water in all its dimensions.

Successes Stories

A bottom-up approach has been employed for the development of the Memorandum of Understanding that will be signed by the 9 partners involved: it will not represent a political agreement, but on the contrary a real commitment of the whole community. It will serve as basis for the sustainability and the long-term perspective of the institutional relations created and strengthened during the project.

Purposes

Working Together for Development is a multi-annual development project which aims at improving their capacities to act as development agents in and outside Europe, in partnership with European and national institutions.

WTD is based on ALDA's long term vision of development and the method of multilateral decentralised cooperation. The project uses a multi-stakeholder approach and focuses on creating strong partnerships between Local Authorities and NGOs. Local Authorities and NGOs have extensive knowledge of their local communities, and their joint activities and cooperation play an important role in the field of development.

WTD aims at giving a real contribution to the empowerment of local stakeholders to act as development agents. All the activities in the project will address local actors who already play a role, or have the potential to play, in local development. The project will target development NGOs and Local Authorities and will reach participants through the members and networks of the partners and associates in the project.

Activities

International seminars and conferences will be organised to share best practices on local development issues, such as women and youth empowerment, sustainable tourism and rural development. Moreover, international and regional thematic workshops will be organised to exchange experience and provide the participants with further expertise on these issues.

During the project eight national and regional working groups will operate as platforms to discuss development issues related to their region and plan activities to be carried out at the local level in partnership with private and public actors.

More than 30 local activities will be directly funded by the WTD project through sub-grants. Local Authorities with up to 30.000 inhabitants and local development NGOs will be invited to submit project proposals with activities focusing on issues such as:

With this project ALDA, together with the 21 partners and associates, launches a new joint Alliance aimed at capitalizing and improving the joint experience and methods of actions developed during the last two decades by Local Authorities and Civil Society Organizations in development cooperation. The WTD Alliance aims at fostering the joint role of Local Authorities and Civil Society Organizations as promoters of democracy, social justice and human rights. It also favours cooperation among all types of LAs and CSOs in order to

bring their best practices of cooperation to European, national and regional institutions, focusing on influencing their development policies consequently.

The Alliance aims at playing a relevant political role at the EU level, as well as at the national and regional level when it comes to the promotion of good collaboration among LAs and CSOs in cooperation to development.

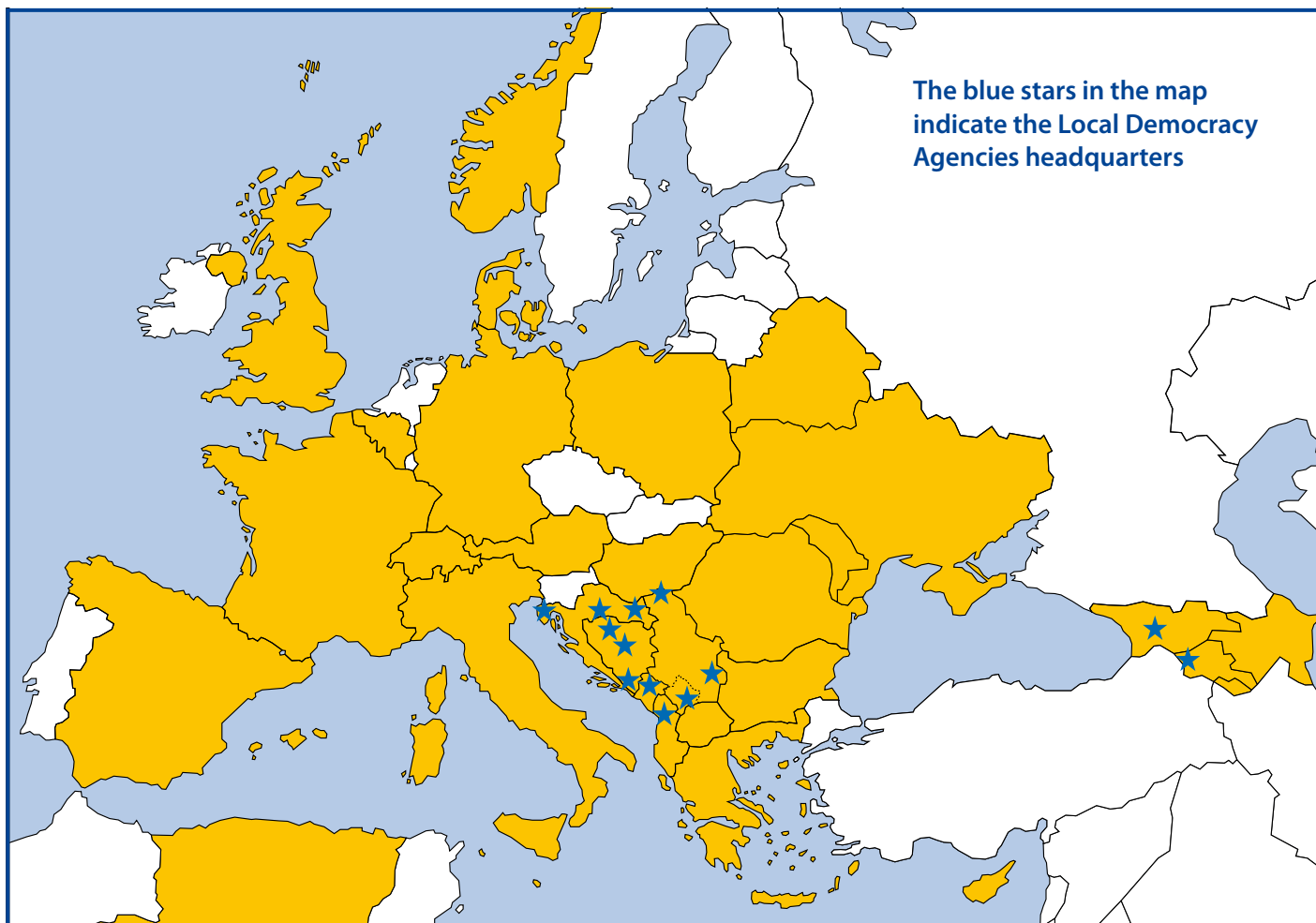

Therefore the process of establishing the LDA has been an intense and complicated, but for sure also enriching process and experience.

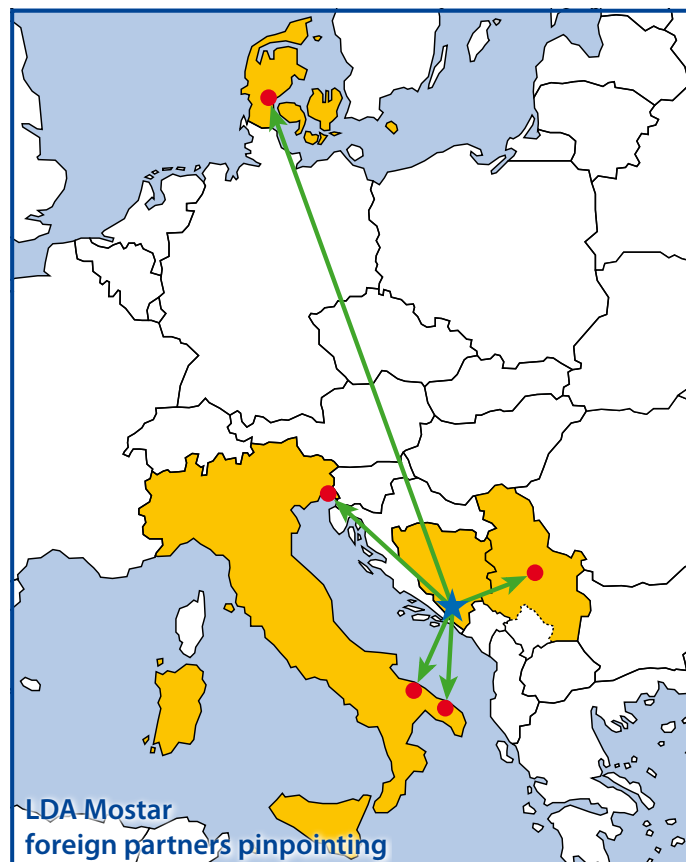
