Statement by the Secretary General of ALDA Antonella Valmorbida, on the Russian Federation's Local Elections in Annexed Ukrainian Territories

As the Secretary General of ALDA, I would like to address a matter of great concern that has recently come to our attention: **the decision by the Central Election Commission of the Russian Federation to organise local elections in certain Ukrainian territories**, specifically parts of Donetsk, Luhansk, Kherson, and Zaporizhzhia regions. This decision has raised significant questions about its conformity with international law, as well as the broader implications for regional stability and the well-being of the affected communities.

ALDA completely agrees with <u>the statement</u> made by the President of the Congress of Local and Regional Authorities of the Council of Europe, Leendert Verbeek, and condemns the decision of the Central Election Commission of the Russian Federation to organise local elections in parts of the Donetsk, Luhansk, Kherson and Zaporizhzhia regions.

The Association emphasises its commitment to the principles of international law, including respect for the sovereignty, independence, and territorial integrity of nations. We firmly believe that the aforementioned territories are an integral part of Ukraine, as recognised by the international community. The situation on the ground, marked by unresolved conflicts and territorial disputes, further complicates the path to a peaceful resolution. We urge all parties involved to engage in dialogue and diplomacy to find lasting solutions that adhere to international norms.

It is our belief that holding local elections in territories under disputed circumstances may pose significant challenges to ensuring truly democratic processes and the meaningful participation of citizens in the governance of their communities. We advocate for a

As stated in our **Flagship Initiative in Ukraine**, ALDA has the goal and will to open seven more LDAs in Ukraine as instruments to promote peace and cohesion, helping to foster understanding, cooperation and ultimately a brighter future for all those affected by the ongoing crisis.
