

# FOREWORD

#### **DŽENANA DEDIĆ**

The Local Democracy Agencies in the Balkans began their mission during the war of the 1990s, a time marked by the collapse of one society and the creation of new ones. Along with deep personal traumas, the establishment of new states on unstable foundations with different socio-political visions meant that the Local Democracy Agencies in the Balkans faced a daunting challenge: to create a society with equal rights and opportunities for all. Established in 1992 by the initiative of the Congress of Local and Regional Authorities of the Council of Europe, the LDAs aimed to support local democracy, human rights, and sustainable development.

LDA Mostar was established in 2004 as the eleventh Agency to be founded, with a relatively clear organisational path and mission. However, its work in the city of Mostar was far from easy or straightforward. The divided local community—burdened by personal and collective traumas, conflicting visions of future development and governance, and constant political and social tensions—was not a favourable environment for an organisation whose mission was to establish a democratic society. Though the context was difficult, it was also stimulating and challenging, which for us became a powerful motivation to persevere. We committed ourselves to those who live, work, learn, and raise future generations in this city-those who truly deserve a safe environment that fosters growth and development. All our efforts have been made for the citizens of this city. After 20 years, we are particularly mindful of this, having been present not



only in Mostar but in numerous local communities across Bosnia and Herzegovina and in the region through our partnerships.

Over the years, we have implemented more than 120 projects, built over 800 partnerships, organised countless events, and reached hundreds of thousands of beneficiaries, participants, collaborators, and friends, alongside donors who supported our work. Our activities have spanned various thematic areas, engaging all sectors of society, but always with one goal: to inspire citizens to become active and local authorities to be open and responsive to the needs and challenges of the community. To make this process possible, we have worked for years with local governments to update and create sustainable mechanisms that ensure meaningful and competent citizen participation in decision-making and policy creation.

All of us - local authorities, civil society organisations, and citizens — share not only equal rights but also the responsibility to contribute to building the communities in which we live. It is only when we fully embrace the importance of using democratic mechanisms in our everyday lives that democracy will become the living culture of our society as a whole. Stronger, more prosperous local communities ultimately contribute to real global progress.

These first 20 years of dedicated work and commitment to a vision of equality and inclusion have equipped us to take on even greater challenges. We are ready to support all those who need it and to serve as an experienced partner to those whose support we seek.

We remain steadfast in our belief that only through genuine cooperation and mutual understanding can we build thriving communities and a more just society. Relied upon as a trusted and efficient partner with more than

### LAYING THE FOUNDATIONS FOR LONG-TERM CHANGES AND IMPROVEMENTS IN BOSNIA AND HERZEGOVINA

Good governance in public administration is the foundation of sustainable institutional development and a key aspect of Bosnia and Herzegovina's integration into the European Union. Although it began as a local initiative, LDA Mostar quickly transcended its local framework, expanding its activities throughout the entire territory of Bosnia and Herzegovina, as well as on the international level. Evidence of this is the successful implementation of several local and international projects that have made a significant impact on various segments of our society.





LDA Mostar's commitment to the democratisation of institutions and capacity building for the adoption and application of good governance principles has positioned it among the leading organisations in this field. One of its most significant contributions has been through the "European Label of Governance Excellence" (ELoGE) program of the Council of Europe, which recognizes and rewards local authorities demonstrating excellence in applying good governance principles. Through the evaluation of local governments within this program, LDA Mostar has facilitated the strengthening of local authorities' capacities.

Additionally, LDA Mostar contributed to the implementation of the first and second Citizen Assemblies of Mostar, as the first Citizen Assemblies in Bosnia and Herzegovina. These assemblies, held in Mostar in 2021 and 2024, represent an innovative approach to participatory decision-making, allowing

citizens, as active participants, to directly shape policies and decisions that affect their community.

Over these twenty years, LDA Mostar has significantly contributed to promoting good governance principles, creating a foundation for long-term change and improvement in Bosnia and Herzegovina.

It is particularly important to highlight that LDA Mostar has maintained a strong sense of local patriotism and continues to selflessly invest in the development of the local community, especially in Mostar, where it began its activities. This organisation remains deeply rooted in the needs of the local population, consistently striving to create conditions for a better life at the local level while also setting standards for the rest of Bosnia and Herzegovina.

Their dedication and commitment to this goal make them an indispensable actor in the process of democratisation and building a better future for all of us.

## PARTICIPATORY DEMOCRACY, A NEW FRONTIER FOR AN EMPOWERED DEMOCRACY

Democracy is often considered to be at stake nowadays, due to both internal and external factors. On the other hand, Europe remains firmly committed to preserving it as a fundamental aspect of unity and to attracting neighbouring countries like Bosnia and Herzegovina into its community. Despite the numerous challenges we face, ALDA supports this form of governance as the best one to protect citizens and their collective aspirations for a broader good and welfare. We are convinced that if our European model is not enshrined in Human Rights, Democracy and Rule of Law, it risks losing its very purpose.





Representative democracy and elections represent a specific moment in time, a very important one. They must occur regularly, be well-prepared, and ensure transparency and fairness in a safe environment for all. That already requires significant effort, and we take pride in our Local Democracy Agency in Mostar, which has played a key role in holding both local and national elections by providing information, raising awareness, and fostering open dialogue. The role of the media is also essential in this process. However, democracy extends beyond just elections; we are called to pursue a deeper, more enduring democracy that lasts throughout all mandates! In this context, civil society is essential and should act as a counterpart to elected local leaders. This deeper democracy is embodied in what we call participatory democracy.

Indeed, between two election cycles, there exists a vast potential for cooperation among citizens, associations, various groups, and the teams, councillors, and mayors of our cities. This cooperation is urgent and absolutely necessary. This is the case in Europe, in Western Balkans but it also represents a global trend.

Participatory democracy is essential for several reasons. Resources for local institutions are scarce and in order to address all problems, strategic partnerships and valorisation of various components of communities are essential. Our societies are more and more complex with different layers of social, economic and cultural levels. In this context, articulated and different forms of governance, in a multistakeholder approach, are essential. The elected leaders can no longer count on a totally hermetically closed mandate for their work. They must engage with citizens and associations to build and adapt their public policies in response to the evolving dynamics of society. We even saw a tremendous speed in changes and events around us, including the impact of digitalisation. That implies not only international developments but also local ones (such as recent effects on climate change in our territories, which impacted Bosnia and Herzegovina as well). Participative democracy, with consultations and various forms of people engagement, allows to seize the momentum. Local authorities have a lot to learn and to earn from ongoing dialogue and policy co-creation with civil society. This is why we strongly advocate for this direction, but also actively engage with our Local Democracy Agencies in Western Balkans, in particular with LDA Mostar, which has been essential in establishing participatory mechanisms at the local level for improving public policies and for solving problems together with the local institutions, such as through citizens' assemblies.

Participative democracy and engagement of civil society gives its best at the local level and it can really change the community to the best.

We wish to continue the endeavour alongside LDA Mostar to support local communities in Bosnia Herzegovina in addressing problems and finding together the solution for both the present and the future.

LDA Mostar is accredited to implement <u>Electionville</u> <u>program</u> with the consent of the Swedish Institute, the Embassy of the Kingdom of Sweden in Bosnia and Herzegovina, and the Swedish Embassy in Bosnia and Herzegovina. LDA Mostar has the approval of the Ministry of Education, Science, Culture, and Sport of Hercegovina-Neretva Canton (HNK/Ž) to implement the Electionville program in all high schools in Mostar, with the possibility of implementation in all high schools in the HNK/Ž area. In 2021, LDA Mostar organised three Electionville events in <u>Mostar, Sarajevo</u> i <u>Banja Luka</u> with 50 direct and over 150 indirect participants. In 2024, LDA Mostar conducted a series of Electionville events title <u>"What is Democracy for Youth – Electionville?"</u> involving 17 high schools in the Mostar area, with over 90 students and 25 teachersmentors participating, significantly raising awareness among youth about the importance of active participation in local decision-making.



# <u>ELECT</u> <u>MOSTAR</u>

Driven by the fact that local elections had not been held in Mostar for many years, and that its citizens were denied the right to vote and to run for local office, LDA Mostar organised an initiative in 2016 titled <u>"Elect Mostar"</u> collecting votes from citizens on issues important to them and their city. The goal was to restore the fundamental democratic right of the citizens of Mostar to choose and to be chosen. The action was highly recognized by local and regional media, as well as by the international community and foreign representatives in Bosnia and Herzegovina. The absence of a response from political actors and leading political options in Bosnia and Herzegovina was evident.

Over time, this initiative grew into a coalition and became a platform that amplified the voices of disenfranchised citizens. Through a series of discussions and negotiations with international actors, four years after the launch of the "Elect Mostar" initiative, the voting rights of the people of Mostar were finally restored. Based on this initiative, the Council of Europe, in collaboration with LDA Mostar and other local partners, organised the first Citizens' Assemblies in Bosnia and Herzegovina, specifically in Mostar, which became a successful example of implementing a deliberative democratic process.











# III. POGLAVLJE ACTIVE YOUTH

Active Youth - the Driving Force of Community Development



Over the years, we have focused on strengthening the capacities of young people through non-formal education, entrepreneurial initiatives, and civic education, providing them with the skills and knowledge to drive positive change.

In the area of non-formal education, LDA Mostar has implemented tailor made programs, training sessions, workshops, and youth exchanges aimed at building critical thinking, leadership, and social responsibility among youth. A key part of these efforts is civic education, which encourages young people to take an active role in their communities. By learning about democratic processes, rights, and responsibilities, youth become empowered to participate in local governance, advocate for change, and lead community initiatives.

LDA Mostar also strengthens the capacities of young people through art and culture, which are powerful tools for social engagement and community building. By implementing creative programs, workshops, and organising cultural events, LDA Mostar provides young people with a platform to express their ideas while addressing social issues. These initiatives foster a sense of belonging and empowerment, enabling youth to take an active role in shaping the cultural landscape and contributing to the overall well-being of the community.

Recognizing the importance of youth entrepreneurship, LDA Mostar has also focused on developing business skills through tailored training, mentoring programs, and networking opportunities. Our initiatives equip young individuals with essential entrepreneurial skills such as business planning, project management, and digital literacy, preparing them to navigate the complexities of the modern labour market while nurturing the spirit of innovation.

Through these capacity-building efforts, LDA Mostar has been pivotal in creating a generation of young people who are not only ready to contribute to the local economy but are also dedicated to leading social and civic transformation through active engagement in their communities.

## NOTHING ABOUT YOUTH WITHOUT YOUTH!

"Nothing about youth without youth!" is a motto that the Local Democracy Agency Mostar has been striving to implement for 20 years, continuously and consistently. This motto is both a call for young people to engage in political action and civic activism, and a warning to decision-makers that any issue concerning youth (and which issue does not concern future generations?!) should be proposed and developed in collaboration with young people and/or accepted by them. Under such guiding principles, the chances for the existence and survival of youth in Bosnia and Herzegovina are increased (the issue of brain drain and the overall emigration of young people from BiH has long been recognized), and their goodwill and capacity for building and long-term nurturing of the local community for the benefit of all its citizens are

#### developed.

However, in Mostar, the situation in this area has not been encouraging over the past two decades—young people are often not even asked for their opinions when important decisions are being made, and in the rare cases they are consulted, they frequently do not respond. In other words, a significant percentage of youth feels they have no impact on important decisionmaking, even regarding issues that concern them directly. They also do not believe that meaningful change is possible, and as a rule, they do not inform themselves or engage in social processes (i.e., they do not contact politicians, do not attend public meetings, donot participate in public protests, budget discussions, etc., do not sign petitions, do not gather signatures for petitions that interest them, do not engage in political





discussions online, do not write articles in newspapers or online portals about issues and problems that affect them, and do not even exercise their civic right (and fulfil their civic duty) to vote in elections). Thus, we have witnessed in Mostar for many years that silence is not, after all, golden.


Bearing in mind the layered, complex, and long-lasting nature of this social problem, the role of the Local Democracy Agency Mostar is extremely important-this tireless team (primarily capable, energetic women) has been steadfastly steering and adjusting its course to respond to the changing winds of social pressures and challenges for 20 years. Therefore, this chapter offers a brief overview of numerous notable projects and initiatives that LDA Mostar has successfully implemented-independently or with partnerscontributing to the development of youth capacities by providing opportunities for non-formal education in various fields: democracy and human rights, entrepreneurship, art, culture, and the environment, as well as through study trips and networking with youth from BiH, the region, and around the world, through the exchange of experiences and constructive ideas, and by





providing training and opportunities for active youth participation in various social processes in their local community.

There is hope that LDA Mostar will continue its dedicated and successful work in the coming decades, in an increasingly favorable social context, and be a support for young people in co-creating a society of equality and inclusiveness in Bosnia and Herzegovina, where young people will be empowered, educated, perceptive, responsible, productive, media and administratively literate, and motivated citizens who think globally but act locally, consistently striving to be part of the solution rather than part of the problem.


